During her time as membership chair, she helped develop the Discover Rotary, Red Badge, and Orientation programs for new members of the club.

Renee was Assistant District Governor, Area 10 from 2016-2019, and is the Rotary Leadership Institute district chair. She is an RLI graduate, faculty member, and helped write the Faculty Training Guide for RLI Faculty, as well as assisted with the RLI online curriculum development. CITATION GOALS AND INSTRUCTIONS



To be eligible for the Rotary Citation, clubs need to begin the year as active clubs in good standing – or having paid each invoice balance in full upon receipt. To verify that your club is in good standing, check your daily club balance report under Club Administration > Club Finances. You should have an outstanding balance of \$0.00. Invoices are due when they are posted, in mid-January and mid-July.

Rotary club leaders can go into Rotary Club Central and select at least 13 out of 25 goals they wish to apply toward citation achievement. This flexibility allows clubs to choose the goals that are most relevant and achievable. In addition, many goals will be self-reported by marking "achieved" in Rotary Club Central.

To achieve the citation:

- Go to Rotary Club Central
- Review the 25 available goals
- Select at least 13 goals (or more than 50% of the available goals)
- Achieve those goals
- Report achievement in Rotary Club Central

Once you are in Rotary Club Central, navigate to the **Goal Center**, select the **year**, and click on the **All tab** to see the goals.

Understanding the Rotary Citation



This guide should provide a quick understanding of how to qualify for the Rotary Citation in 2021-22. Here are the important things to know:

- To qualify, your club must set and achieve its **own goals** in at least <u>13</u> of 25 Goal Categories (half of the categories). You may select categories important to you and set your target level of achievement in each.
- Achievements in each category must be entered by the club in Rotary Club Central, except for Membership, Annual Fund and PolioPlus contributions which will be updated from Rotary.org data in real time.
- Set a goal in each of at least 13 categories more categories if you wish (you only need to accomplish 13).
- Enter your club's accomplishments in Rotary Club Central by **June 30, 2022**. When you've achieved your goals in at least 13 categories you qualify for the Citation. **Important**: If you're counting on a Membership achievement, your membership must be sustained through June 30, 2022. A late termination or two sometimes trips clubs up.

----- Goal Entry Process -----

- 1. Start at Rotary.org/ClubCentral
- 2. Log in. If you're unable to log in, you may need to Create an Account in My Rotary use the "REGISTER FOR AN ACCOUNT" button, follow the prompts and watch for a confirming email.
- 3. Click Goal Center on the left navigator:
- 4. Change the year at the top to 2021-22. You may need to click the "All" tab on the right. An editable list of all 25 available Goal Categories will open.
- 5. Check the Select Goal box for those you intend to pursue. Remember you can choose as many Categories as you wish, of which you must achieve 13.
- 6. Note the **"Show goal details and history**" link that provides data for prior years that will be helpful in arriving at realistic and achievable goals:

Rotary provides an opportunity for all of us to provide service to our community and throughout the world (Service Above Self). With that service comes a learning experience in the areas of leadership, team building, planning, marketing, communication, and organization. RLI provides an opportunity to enrich that learning through sharing experiences and ideas with other Rotarians throughout the region.

The RLI Program

The Zone 33 Rotary Leadership Institute conducts over 25 events each year in the states of Delaware, Maryland, North Carolina, South Carolina, Tennessee, Virginia, West Virginia, and The District of Columbia. The program consists of the separate sessions, Part I, Part II, and Part

III. Attendees progress through the three part on separate days and complete the program at their own pace.

Each session is highly interactive and, therefore, contains a minimum of lecturing and provides lots of opportunity for participants to share their experience and ideas. Purpose of the visit:

□ To allow the District Governor to communicate directly with all Rotarians in the district and answer questions about Rotary International and District 7750.

□ To listen to club leadership and gain a better understanding of their club.

□ To encourage Vibrant Rotary Clubs through membership group and member engagement.

Preparation for the visit:

• The Assistant Governor for the area will work with the club leadership to confirm the meeting and any special arrangements.

□ The District Governor **is the program** for the Official Club Visit. Please do not schedule another program to take place for their visit. Please allow 30 minutes for the Governor's Program.

□ Communicate any special plans you have to the Governor and AG to make sure it fits in with his other plans.

□ DG Frank will meet with the board of each club to discuss the club plan, membership, Foundation, what's going well, areas that need extra attention. For lunch clubs, this special Board meeting will take place 90 minutes before the start of the Club meeting unless special arrangements have been made. For breakfast clubs, the special board meeting can take place the night before or after the club meeting.

Introduction of the District Governor and the meeting:

• Biographical information will be provided to the Club President and Assistant Governor in advance of the meeting. The Assistant Governor will handle the introduction of the District Governor unless other arrangements have been made.

• It is customary that the Rotary Club members stand when the District Governor is introduced and when he has completed his presentation. This form of respect is shown because the District Governor is acting as the official representative of Rotary International President Shekhar Mehta.

• Presentations of Paul Harris Fellowships, inductions of new members and other honors for Club members are especially appropriate during the District Governor's Visit. Celebrate your Club's successes!
