Let's make data-based decisions

How many psychiatrists does it take to change a light bulb? Only one, but the light bulb must want to change.

Once an organization decides it's not satisfied with the status quo, it's cleared a major hurdle. Then the question is, "What's wrong? and how can we fix it?" At that point a group dynamic sometimes takes over where the most assertive, most vocal, or perhaps most senior member of the team says, "Here's what I think we need to do", and essentially dares others to differ.

Well-meaning people mis-diagnose problems all the time, usually because they're coming from a limited perspective or flawed assumptions about the situation. The solution for that problem? Analysis. Careful analysis, actually looking at available data that reveals what's really happening. That's why doctors do more than look down your throat when you have a serious disease.

Let's take a Rotary club that's failed to grow membership or, worse, yet, has been declining in membership for several years. How would you analyze that?

Start with 10 years of membership records. Those are available from the district database (DaCdb). Let's look at everyone who's been in or left the club for 10 years. What do we see? I've looked at several of these, and seen some different patterns.

In one club, I found entire 12-month windows where they didn't bring in any new members. Wow, what's going on (or not going on)? When a small business isn't growing, it's either a problem with the product or a problem with "lead flow," meaning that they don't have ways of finding

enough new prospects to meet their growth needs. If you can't find prospects faster than customers leave, you can't grow. Same in a Rotary club.

How many prospective members have you seriously pursued in a year? Do you have that data? If the answer is "not many," then lead flow may be the problem. What's needed is an intentional strategy to connect with more potential prospects. To get more hits, you need more at bats. Then, you'd want to actually track how many prospects the club pursues in a month or a quarter.

If, on the other hand, you've had a lot of prospects but just couldn't get them to join, the problem may be the product. Ask, "What's the club's curb appeal? "Is the vision inspiring enough to attract a new member?" "What do we have to sell? — Why would someone want to be part of

this?" You may find that the club just isn't vibrant enough to attract and retain members, or may have lousy programs or an unattractive meeting place.

Looking at the data is always revealing. I saw one club that had a steady flow of new members. They also had a steady flow of members exiting after only a few quarters. That's a problem with the product. In this case, the problem was bad enough that the number of people who had cycled through the club in three years came to 80% of the total membership. Wow, that's something that needs a deeper look.

Look at the data. Ask why you're seeing what you're seeing in the numbers. Data is your friend, if you give it a chance to speak to you.

District 7750 members have given \$70,461.56 (interim report for June) to PolioPlus this year.

To remind everyone how important giving to PolioPlus is, Rotary News reports: "Rotary is releasing \$40.3 million in grants to support polio immunization activities in 10 countries, including Afghanistan, Nigeria, and Pakistan, three countries where the disease has never been stopped. The funds will help build on gains Rotary and its partners have been making in the fight to eradicate polio. ... In addition, the money will support immunization activities in countries still at risk including Cameroon, Chad, Democratic Republic of Congo,

Ethiopia, Niger, Somalia, and South Sudan."

As we end Rotary year 2014-15, I thank you for your contributions to PolioPlus. Although we had fun raising funds through our celebration of Rotary's 110th Birthday, we were a little short of Gov. Tom's goal of \$88,751. So I challenge you individually and as clubs, let's start early to meet Gov. Terry's goal of \$50 a person. Your contributions ARE making a difference.

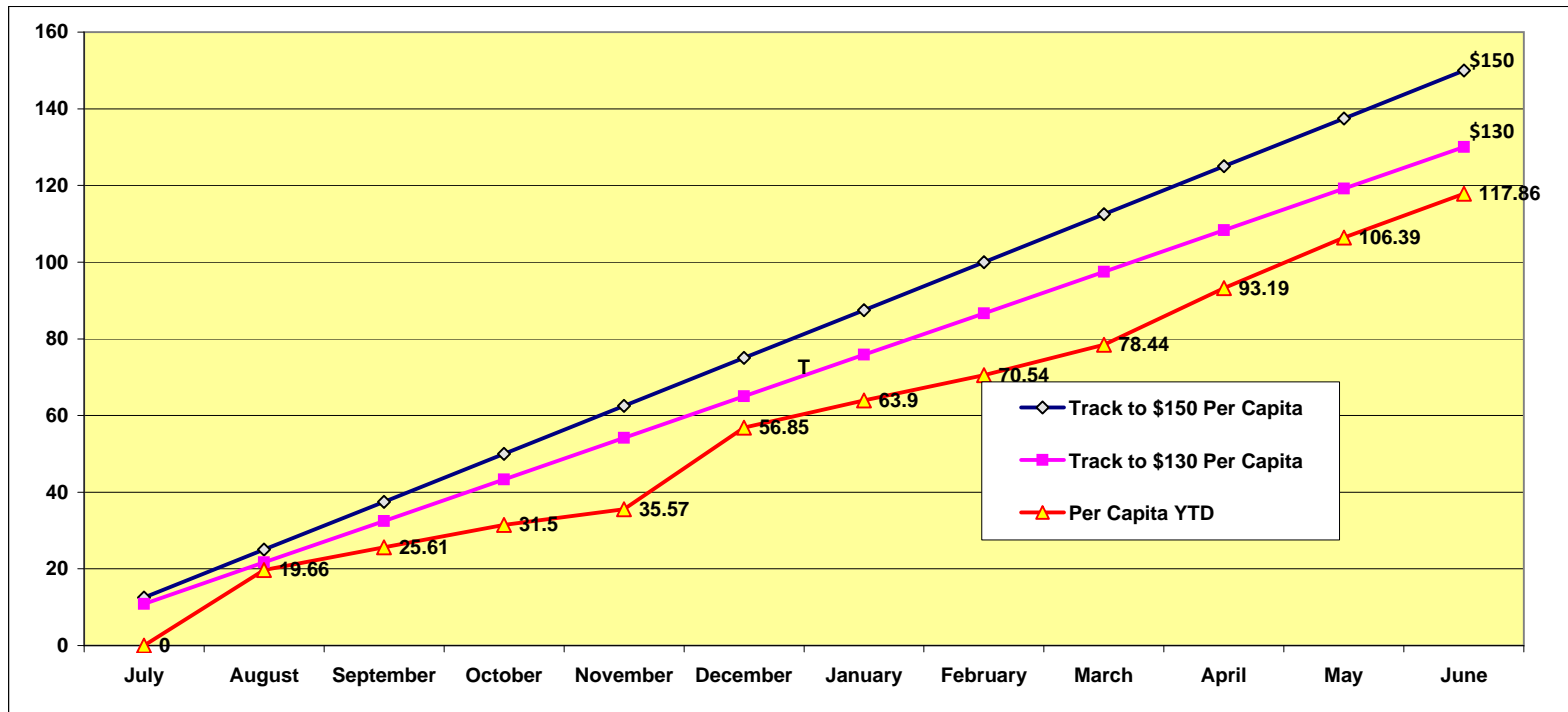

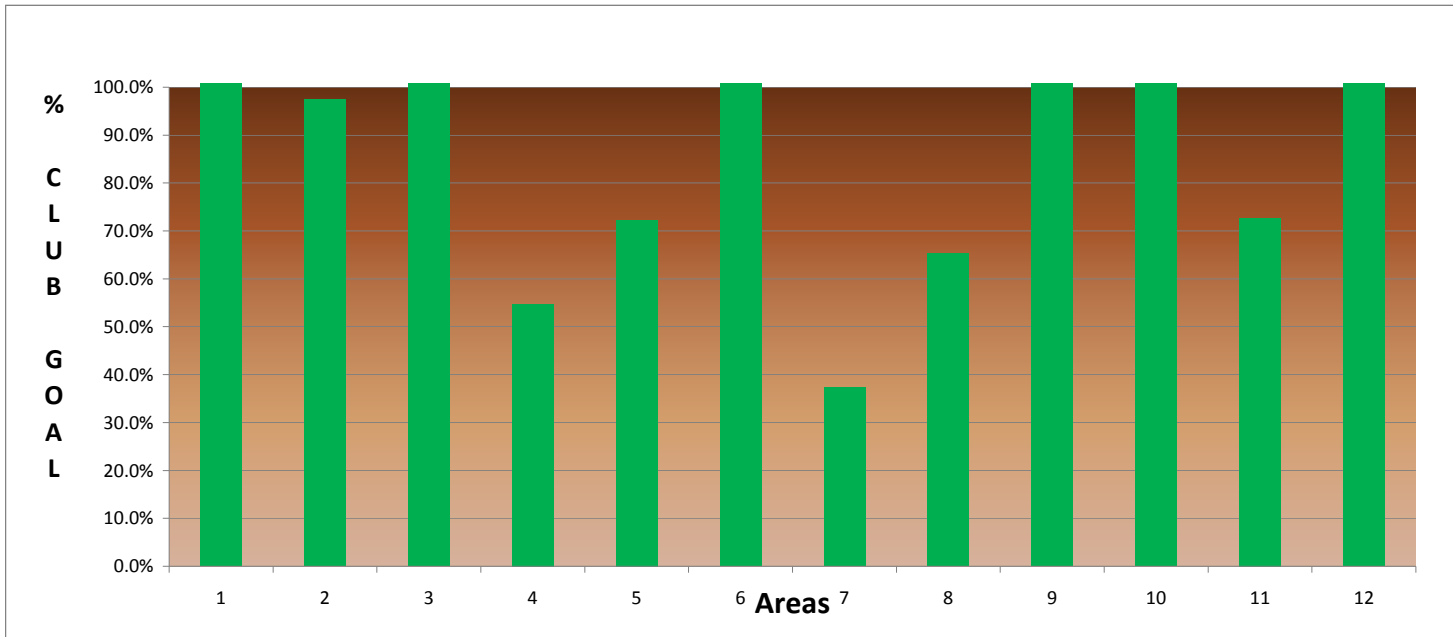

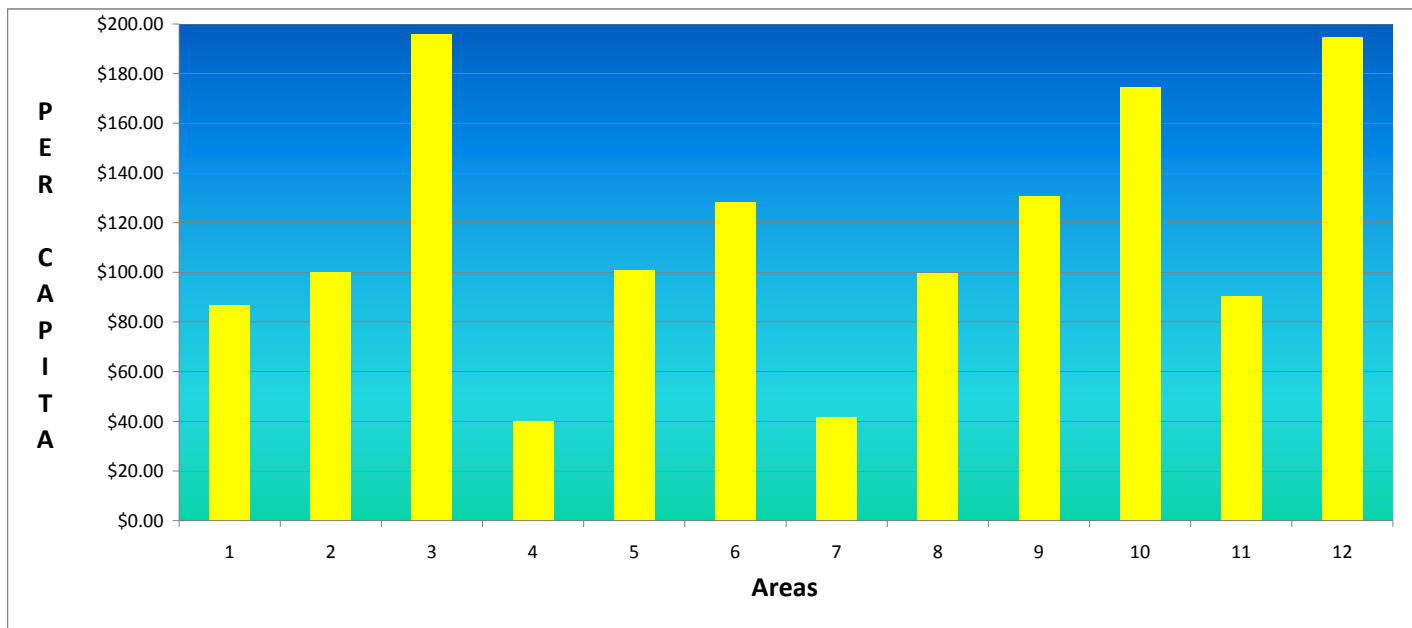


% of Club AF Goal Achieved - By Area
