MEMBERSHIP NOTES

Two signs of a healthy, vibrant club

In previous editions of this year's newsletter, The Membership Note identified the importance of healthy, vibrant Rotary clubs. These clubs experience growth by attracting and retaining members. They are clubs whose members enjoy being a Rotarian. This is not the case in all clubs. It takes intentional strategies to build and maintain a healthy and vibrant club. Club leadership can and must set the conditions for this to occur.

There are many resources available to the club leadership that help address intentional strategies to set conditions for a healthy, vibrant club. The intentional strategies listed in the Grow Rotary Action Team, GRAT, section of the District website provide strategies that have worked for many clubs.

Also, there is a wealth of information that can be obtained from My Rotary on the RI Website. The Membership Best Practices Discussion Group is one. It can be found by following the chain My Rotary/Exchange Ideas/ Discussion Groups. I recently ran across the following discussion that addresses retention. It is copied from the website as posted.

"I don't think there is one simple answer to your question about retention of new members. Because each person's motivations, interests and preferences are different, there could be several factors for each person that are contributing to turnover. You could assess your club against the 12 engagement factors identified by the Gallup people to see where you have strengths and weaknesses.

And/or, with new members, and each year with all members, have a one-on-one discussion asking them questions like What/how do you want to contribute this year? What do you want to get from your Rotary experience this year? What can you do to make this happen? What can we do to help you make this happen? Overall, how satisfied are you with your Rotary experience? What would it take to make this an even better year for you? What can we start doing/do more of, stop doing/do less of? And what should we continue to do?

This all gets documented and the Board tries to match people's interests to opportunities throughout the year.

Another idea would be to have exit interviews. Anytime anyone leaves ask them over a cup of coffee to learn why specifically they decided not to continue. If you explain it is for the purpose of helping the club improve, I think most people would be agreeable to this—and would probably leave them with a pretty positive impression of Rotary."

Club leadership should adopt some, if not all, of these suggestions to help set conditions for retention that are essential for a healthy, vibrant club.

Rotary STRENGTHEN YOUR CLUB

GRAT every Rotarian has access to materials to help grow your club

Your Rotary District 7750 **GROW ROTARY ACTION TEAM** has a wealth of resources to apply in working with individual clubs on membership development. These resources are available to all Rotarians and clubs in the District; are comprehensive and when effectively customized, can truly make a difference in a professional approach to membership initiatives.

In particular, Strategies/Ideas for Building Rotary Membership provides a lot of substantive help. **Click here** to go to the Grow Rotary Action Team (GRAT) Corner. It is a part of the Information Library for 2016-17 club presidents.

One key GRAT principle is known as the 10-3-1 Rule: You need 10 suspects to develop three qualified prospects in order to secure one new member. This was developed with extensive research in the insurance industry dating back over a span of 25 years. It is still valid today in business and in Rotary. I had the good fortune to learn it in an encore career in insurance and also applied it in Rotary as a membership chair.

Every club has the ability to generate suspects and prospects. One easy way to use the GRAT tool— Who Do You Know Membership Survey—is in a club assembly. Apply what you learn to a well thought out and documented intentional strategy specific to your club. A club assembly with 25 Rotarians present should bang out 100 suspects in 30 minutes, and the top three per member may be quite qualified.

This is akin to Value Investing which is the cornerstone of Warren Buffet's approach to his financial success. It generally involves buying securities that appear underpriced by some form of fundamental analysis. Ken Solow, a great Rotarian, former D7620 District Governor and speaker at last year's D7750 All Club Conference last year has a blog- Ken Solow's Rotary Blog, Ready, Fire, Aim. In April, 2015, he offered what Buffet would say about Rotary. In short, he would rate it a Strong Buy, while pointing to its amazing global structure, underutilized assets and that Rotary doing good in the world has huge upside potential. You can read the entire article and subscribe to his blog at www.kensolowrotary.com which is rich with many good membership articles.

an entrée, the Wine Fellowship suggest the following wines.

WHITE: Reisling: spicy and sweet; Gewurtzaniner: aromatic with gusto; Sauvignon Blanc: citrus based; Pinot Grigio: capable of handling garlic & onions.

RED: Pinot Noir: subtle with earthy undertones, often mushroom inspired; Zinfandel: full bodied and intense red, stronger than pinot noir; Boujoulais Nouveau : fruity red released from France on the 3rd Thursday of November, just in time for the holidays; Sherry: chose extreme extra dry or fruity;

Tip of the month: For red wine spills, cover area with salt. Let dry. Salt absorbs wine. Then use hot water to dab the stain out. Do not rub the stain, only dab.

The Rotary Club of Gaffney donated an AED to Limestone College on Nov. 15.

Providing AEDs is the signature project of 7750 governor Lance Young. Rotary realizes that there is a benefit to its communities in ensuring that victims of Sudden Cardiac Arrest will have a better chance of survival if an AED is avail-able. An AED is portable and virtually fool-proof to operate. Anyone who can listen to the automated voice instructions and press a button when indicated can operate an AED. The unit's voice tells you where to apply the shock pads and instructs you when to press the shock button if defibrillation is indicated.

The funds for the AED were generated through the club's community service initiatives.

Gaffney Rotary Club President Daryl Smith presented the AED to Limestone staff memember Walt Griffin and Kelly Curis.

Rotary Foundation named the world's outstanding foundation for 2016

Our Rotary Foundation was named the world's outstanding foundation for 2016 by the Association of Fundraising Professionals.

The judges cited PolioPlus as a major driver for its selection. That includes YOU—your generosity to helping eradicate polio is an important part of our Foundation receiving this honor.

As you know, this is our Centennial year-long celebration of the Foundation. Every Rotary club is asked by RI President John Germ to set a goal of at least \$2,650, a higher goal than usual in honor of the centennial and the need world-wide.

Global Polio Eradication Initiative (GPEI), of which Rotary is a Partner, is working on strengthening surveillance and immunization in Africa and East Mediterranean to ensure polio has been eradicated and immunity against the virus improves.

We still hope to complete eradication during 2017 even with the discovery of 4 polio cases in the Borno region of Nigeria. Vaccination activities continue and new innovative technology is being used to ensure workers are getting to areas where vaccinations are most needed. This new technology is a smartphone application called Survey 123 where consultants report weekly, anywhere in the world, on their activities.

Vaccinations continue to be administered amidst insecurity. WHO, UNICEF and partners reached 1.1 million children with the oral polio vaccine in South Sudan this November. Other places with the poliovirus are in countries where conflict and lack of security make it difficult to reach children.

Because of the volunteers and committed workers, there was only 1 wild poliovirus case reported this past week. The total number for 2016 is 33 compared to 74 in 2015.








% of Club AF Goal Achieved - By Area
