


world this year, let's break every Foundation giving record in our district with annual giving, polio, benefactors and bequests.

Have you ever considered what it would mean if your Rotary Club no longer existed? How would your community be affected? Over the years, communities have come to depend and rely upon Rotary clubs for community involvement. When a club begins to lose its effectiveness due to decreased membership, it impacts not only the club but, also the community.

You have heard it said that membership is the #1 priority in District 7750. Despite the emphasis on membership, currently over one half of the District's 52 clubs are experiencing either no change or a net loss of members since the beginning of the Rotary year. Do you know where your club now stands?

The problems with decreasing membership can be solved. There are intentional strategies that have been proven to work and have been used successfully by clubs in our District. They address each and every membership problem, except one, and that is lack of engagement by individual Rotarians.

Every Rotarian is a de facto member of his/her club's membership committee. It is incumbent on each and every one of us to play a role in keeping our clubs healthy and vibrant so that they continue to be a positive presence in our communities.

Right now your club should be planning for a District Membership Event Grant. Every member has a role to play in this. The success, even failure, to get maximum benefits from the grant falls on the shoulders of each member of the club. It might be as simple as inviting someone to the event or passing along a lead to another member.

Ask your membership chair and/or president what role you can play in membership. It is up to each Rotarian to stay engaged so that Rotary remains strong in our communities. Be the Inspiration in helping your club do this.

Admin and PI: Help your club be excellent

The administration of a club might not be the most exciting part of Rotary and it won't be a primary driver of membership. But a well-run club can very well make the difference between excellence and mediocrity.

The club's ability to promote itself, likewise, might not make all the difference in success or failure but it goes a long way toward helping your community understand your mission.

To help club members get a better grasp on these two important but sometimes overlooked aspects of Rotary, the district is sponsoring a training session on November 10 in Spartanburg.



The Rotary Club of Greenville will present the 2019 Peace and Conflict Resolution Conference on Friday, May 3, 2019 from 8:30 a.m. to 4:00 p.m. at the Greenville Convention Center (formerly TD Convention Center). The mission of the 2019 Peace Conference is to inspire people to resolve conflict in a peaceful and productive manner. As Rotarians, we refuse to accept unresolved conflict as a way of life.

Keynote speakers are highlighted below.

BAWA JAIN will open the conference with a presentation on "Is Peace Possible?" Bawa is Founding Secretary General of the World Council of Reli-

gious Leaders and is founder of the World Movement of Nonviolence. He actively speaks, practices, and promotes Religious Diplomacy around the world as part of his broader thrust on Responsible Leadership.

AZIM KHA-

MISA'S son, Tariq, 20 was killed by a 14-year-old gang

member in a gang initiation ritual. Since then, Azim has authored four books and speaks worldwide to students and adults on nonviolence, forgiveness and peace-building. Azim will speak on "Forgiveness as the Foundation of Peace" and on his journey to becoming a passionate peace activist and a teacher of nonviolence and forgiveness.

DAVID FORWARD will discuss his latest book A String of Pearls: Inspiring Stories of How Rotary Peace Fellows Are Serving Humanity and Saving the World. This book honors Peace Fellows by telling their stories. David says, "Like a pearl, which starts out as a minute grain of sand and over time develops through many crystalline layers into a precious jewel, our scholars are a force for good in the world that is rare, valuable, and prized. The Rotary Peace Fellows are a string of pearls."

JESSICA SHRYACK will lead a session titled, "Living Room Conversations: An experimental session in civil discourse." Jessica facilitates face-to-face conversations between people with differing views and experiences, especially around difficult topics. Skills participants will learn include active listening and using ground rules to set the stage for effective conversation. The goal of these conversations is to try to see other points of view by pushing through stereotypes and emotion while not getting so "triggered" that we lose the opportunity to engage others.

An **INTERFAITH PANEL** will feature representatives from Hinduism, Islam, Judaism, Catholicism, and Christianity religions. Although all religions have distinct belief systems, there are similarities and common goals of peace, love, and justice. The goal of the panel presentation is to inspire others to understand "we" are all in this world together and that

> harmony begins with each of us, regardless of our religious affilia-

Captain D. F. PACE is an 18-vear veteran of the Philadelphia Police Department. He is Commanding Officer of the Department's

Police Board of Inquiry. D.F. spent three months at Chulalongkorn University in Thailand as a Rotary Peace Scholar where he earned a professional certificate in Peace and Conflict Studies. He will speak on how he took the lessons of the Rotary Peace Program to the streets of Philadelphia and how that training has influenced and been applied throughout his career in law enforcement.

VIKAS SRIVASTAVA will speak on "Transforming Violence." He will offer ideas to transform the past into a non-violent future by redefining the essence of violence — including a strategy to end the cycle of violence while healing the past and preventing similar violence from reigniting.

Holiday gift idea: A Rotary license plate

It is time to think about holiday gifts for Rotary friends and for suggestions to family to give to you. You would lose the element of surprise, but I have a suggestion to give your Rotary friends or to suggest to your family to give you. Consider a Rotary South Carolina license plate.

The extra expense to get the plate is \$50 in addition to your registration fee. The receipt of the plate starts a new registration cycle which so you will owe a small amount to extend the registration period out to the full term.

To obtain the plate, you must download a form from SC DVM at http://www.scdmvonline.com/DMVNew/forms/MV-95.doc. The form is very straight forward. Once it is completed, you take the form to your local and pay the \$50 and whatever extension charge is due on your vehicle's registration.

Once you get your tag you will need to notify the District of the new plate so we can verify the transfer of funds from the State to the District and proper application of the funds. We are working on documentation of this process at the moment, but for now, you just have to let us know.

Club Officer & Director Elections

It's time to kick off the election process for club officers and directors for the coming Rotary year (beginning July 1). Your club bylaws require that a least four officers plus directors for the coming year be elected no later than December 31. Those officers are **president**, **president-elect** (to follow the elected president), **secretary** and **treasurer**. Excerpts from the relevant section of the Standard Club Bylaws are at the end of this article.

Start right away - you need time to assemble a nominating committee, confirm with possible nominees their willingness to serve, present a slate of candidates at a meeting and publish the slate in a bulletin -- all at least **one month** before the election at a meeting (in December).

An effective Rotary club has its president line in place for at least 2 years in the future, so it's important to not only elect a president for the coming year, but also a president-elect.

An effective Rotary club also has a Board rotation/replacement process in place. Depending on Board terms (2 or 3 years), some number of seats need to be replaced every year. A Board position is a good way to get an emerging leader up to speed on the workings of the club.

The president, immediate past president, president-elect, secretary, and treasurer are automatically members of the Board.

IMPORTANT: The nomination process, securing commitments from those nominated and the election process are all responsibilities of the Board of Directors — it's not the incoming president's responsibility to fill any of these positions. The president is responsible only for securing committee chairs.

By the way, if your club's bylaws have not been updated since 2016, they should be, as they're out of date. The 2016 Council on Legislation enacted several provisions that would require an update.

EXCERPTS FROM RECOMMENDED ROTARY CLUB BYLAWS:

Article 2 Board

The governing body of this club is its board of directors, consisting of, at a minimum, the president, immediate past president, president-elect, secretary, and treasurer.

Article 3 Elections and Terms of Office

Section 1 — One month before elections, members nominate candidates for president, vice president, secretary, treasurer, and any open director positions. The nominations may be presented by a nominating committee, by members from the floor, or both.

Article 5 Meetings

Section 1 — An annual meeting of this club is held no later than 31 December to elect the officers and directors who will serve for the next Rotary year.








% of Club AF Goal Achieved - By Area
