## **Giddy-up:** When it comes to membership, don't think of your club as being in a horse race

As we begin the second half of this Rotary Year, we need to look at our current membership situation.

An analogy can be made between our clubs and horses in a horse race. Imagine 50 horses (clubs) at the starting gate back on July 1, 2019 when the race is started.

The current situation is that some horses jumped out and headed for the finish line (membership goal), others turned and ran away in the opposite direction (negative growth), while others just stayed at the gate (zero gain or loss).

However, in terms of membership and clubs it is really a bleak picture.

There is good news. Membership is not a horse race. Clubs are not in competition with each other. They are competing only against themselves. There is still time to ensure that your club crosses the finish line and ends the year by achieving its goal. This can be done by developing a plan that utilizes the intentional strategies found on the District website. It will take every member doing his or her part in making the club stronger and more attractive to potential members. Remember that it is up to all members to introduce potential members to Rotary and ask them to join.

ESRAG— the Rotary Action Group for Environmental Sustainability— has taken on creating awareness for the plight of honey bees. They support plant based solutions and created the program


R4B. Bee populations have declined; and bees are necessary for pollinization.

#### **SPARTAN WEST**

SWITCH is an organization that fights human trafficking and sexual exploitation in the Upstate of SC. In 2018 SWITCH was able to serve 48 survivors of sex trafficking. They provide awareness, intervention and restoration to the community.

The Spartan West club will purchase the recommended items to fill the Freedom Bags. At one of the regular club meetings all members will participate in filling/packing the backpacks that will be donated to SWITCH. The bags are for the women who are rescued and include clothing, feminine and personal hygiene items and a blanket. \$2,500

#### **TWIN CITIES**

Our goal is to provide
a summer program to offer a
quality reading enrichment for
children of the BatesburgLeesville
Community. The program will
provide the opportunity to make
community connections for children
and their parents, provide up

to date literature and research based reading material for the participating children. Parental education will also be included. Serving Batesburg-Leesville Area kindergarten through second grade students. The total budget for this project is approximately \$20,000. \$1,500

#### **UNION**

We propose to purchase grade level reading books for elementary students at Foster Park Elementary School in Union. Our theme is "Dream Big" and plans are to purchase books such as "Dream Big, Little Pig" and "Dream Big: Michael Jordan and the Pursuit of Excellence" among others that fit our theme wich comes from a previous Rotary idea. Plans are to place a permanent Rotary label in each book which will show that Rotarians care about reading. We also anticipate coverage by local news media outlets including two local newspapers and a local radio station. **\$2,500** 

#### **WESTMINSTER**

Westminster Elementary
School is a Title I School in Oconee
County with limited funding for
Arts Education. The music teacher
is passionate about providing
well-rounded music education to
all of her students, specifically

her 4th and 5th grade students. The objective of our project is to purchase a classroom set of guitars for the 4th and 5th grade students at Westminster Elementary School, teach the students how to play, tune, and maintain the guitars, and instill a love of music education in each of the students' lives for vears to come. This will be attained through our club's participation in purchasing the guitars and supporting performances of the students at various events in the school, at Rotary meetings, and in the community.

This project is in line with Rotary's commitment to education, and meets a dire need in our community. The Rotary Club of Westminster envisions a partnership with Westminster Elementary School, and this project could be the way to open the door to that relationship. \$2,350

#### **WINNSBORO**

The club will purchase books and stuffed animals (Critters) to place in barber shops, beauty salons, and doctor offices for children to enjoy and read with the critters. The project will be centered around Books and Buddies program which offers a reading buddy for every child and adult to enjoy. \$400

## POLIO REMAINS endemic in Afghanistan,

Nigeria and Pakistan. Until poliovirus transmission is interrupted in these countries, all countries remain at risk of importation of polio, especially vulnerable countries with weak public health and immunization services and travel or trade links to endemic countries.

The countries are working to deliver vaccination services to their people, to carry out sensitive disease surveillance and to cooperate to immunize migrating populations across their common borders. Global Polio Eradication Initiative also supports countries that experience or are vulnerable to the rise of vaccine-derived polio viruses (VDPVs), which are rare and only occur when polio vaccination rates are low. When VDPV cases occur, high levels of vaccination, robust surveillance, and rapid outbreak response are critical.








% of Club AF Goal Achieved - By Area
